

**NOTICE OF PUBLIC HEARING
PAMLICO COUNTY
FY 2020-2021 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAMS**

The residents of Pamlico County are hereby informed that the County intends to apply to the North Carolina Community Development Block Grant (CDBG) program for U.S. Housing and Urban Development (HUD) funds under Title I of the Housing and Community Development Act of 1974, as amended. Infrastructure, economic development, neighborhood revitalization and coronavirus assistance funds are available for projects that benefit low- and moderate- income (LMI) persons, prevent/eliminate slum and blight, or address an urgent need. The Pamlico County Board of Commissioners will hold a public hearing on Monday, November 2, 2020 at 7 PM at the Pamlico County Courthouse, 202 Main Street, Bayboro, NC 28515.

The purpose of the public hearing is to explain the CDBG program and allow the residents of Pamlico County an opportunity to express their views concerning community development needs and priorities. Persons having any questions concerning the CDBG Program are urged to attend the public hearing, make their views known, and submit oral/written comments. Residents will be able to leave comments by written method, virtual method, verbal method by contacting Clerk to the Board Courtney L. Norfleet at 252-745-3133; courtney.norfleet@pamlicocounty.org.

Efforts will be made to minimize displacement during project implementation, and displacement assistance as necessary will be available.
