The JCPC anticipates funds from the NC Department of Public Safety, Division of Adult Correction and Juvenile Justice, Juvenile Community Programs section in the amount stated above to fund the program types specified below. Such programs will serve delinquent and at-risk youth for the state **fiscal year 2018-2019** beginning on, or after, **July 1, 2018**. The use of these funds in this county requires a local match in the amount specified above.

**Proposed program services should target the following risk factors for delinquency or repeat delinquency:**

Moderate to severe behavioral problems at school, peer conflict and peer relationship problems, youth under age 12 at the time of their first delinquent offense, substance abuse, inadequate parental supervision

**Programs should address one or more of the following concerns as reported in the Needs Assessments for adjudicated youth:**

Peer Domain: Youth associating with other delinquent youth.

Individual Domain: Mental Health problems, substance abuse

Family Domain: Domestic discord, parental involvement in the criminal justice system, marginal to inadequate parental supervision skills

School Domain: Moderate to serious behavior problems at school.

**Applicants are being sought that are able to address items below:**

1. Program services compatible with research that are shown to be effective with juvenile offenders.
2. Program services are outcome-based.
3. The program has an evaluation component.
4. Program services detect gang participation and divert individuals, if applicable.

**Local public agencies, 501(c)(3) non-profit corporations, and local housing authorities are invited to submit applications to provide services addressing the above elements.**
